# Commitment, cooperation and ambition in terms of international solidarity

### Commitment

After time spent working in sub-Saharan Africa, through the French Ministry of Foreign Affairs, Ludovic Donnadieu, a graduate in accounting and development economics, joined forces with international audit firms and created closer ties with the French Development Agency in the microfinance sector.

Deeply committed and aware of the specific needs of the international solidarity sector in the financial and legal fields, Ludovic Donnadieu decided to fully devote himself to it by establishing a dedicated audit and consulting firm.

### Cooperation

In 2008, Ludovic Donnadieu met René Ricol, director and co-founder of Ricol Lasteyrie, a financial and strategic expertise firm, and a leading figure in the national and international accounting profession.

Driven by the desire to establish a firm dedicated to the international solidarity sector, in keeping with his values and convictions, René Ricol decided to commit Ricol Lasteyrie to the upcoming firm. Thus Donnadieu & Associés was born.


